for the appropriate re-stamping of materials and products for marine equipment and structures according to Lloyd's Register Rules and Regulations for the Classification of Ships

The agreement requires a check of the identity of the material/blanks against the related certificates and compliance with the applicable Lloyds Register Rules and Regulations, Part 2. The ID markings must be transferred prior to removing the original ID marking.

The ID marking transfer to be validated by the entitled employee by registering in the production system acc. to procedure No. P-9.2 Issue 06 and supported instruction No. I.1 Issue 06 which is the part of certified quality management system acc. to ISO 9001:2015.

For the transfer of ID markings of material with quality certificates according to EN 10204 / 3.2 which are not certified by Lloyd's Register, a specific agreement between the Company and its client should apply.

For a complete traceability of the material/blanks, an ID marking transfer record needs to be completed for each re-stamping.

This ID marking transfer record shall include at least:

- Techno code (ID production order number or ID stock number)

The ID marking transfer record and original material certificates must be presented at the final acceptance and certification.

Changes company structure, QC processes or in the entitled persons need to be communicated to Lloyd 's Register Marine Polska Sp. z o. o., Gdansk without delay.

This agreement is valid for five years until 19.08.2030 and subject to annual verification.
